# NOTICE OF UPCOMING WORK

**September 19, 2022**

## **CONSTRUCTING A NATURAL DRAINAGE SYSTEM (NDS) AT SYLVAN WAY SW**

### **PROJECT DESCRIPTION**

As part of the Longfellow Natural Drainage System project, Seattle Public Utilities (SPU) will install a natural drainage system in the public right-of-way on Sylvan Way SW near Home Depot to help improve stormwater drainage and remove pollutants from stormwater runoff to improve water quality in Longfellow Creek. ### **SCHEDULE**

Construction at this site will begin as soon as September 26 and is expected to last through late 2022/early 2023.

### **LOCATION**

Public right-of-way on Sylvan Way SW near Home Depot (see map below)

# NOTICE OF UPCOMING WORK

## ANTICIPATED IMPACTS

During construction, there will be increased construction traffic as well as materials and equipment in the project area. Crews will begin with roadway and drainage work. After this work is finished, crews will complete landscaping and planting.

You can expect the following once construction begins at this site:

- Work will generally occur during weekday, daytime hours
- Construction noise, dirt, dust, and vibrations
- Materials and equipment staged near the road edge near construction activities
- Temporary lane closures near the work area
- Road closure on Sylvan Way SW between Home Depot's eastern access and SW Orchard St. This road closure will occur as soon as September 26 and will last approximately two weeks. The road will be closed 24 hours a day, with local access allowed to driveways east of the closure on Sylvan Way SW.

While most of the work will be contained to the grassy area between Sylvan Way SW and the Home Depot parking lot, the contractor will require temporary traffic impacts to perform work near the road edge. The project team will coordinate with other construction activities in the area to minimize impacts to the extent possible.
